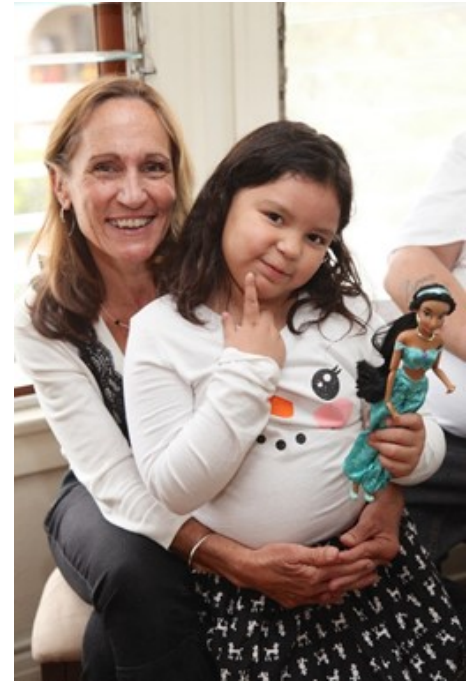

CASA of Los Angeles, founded in 1978, mobilizes community volunteers to advocate on behalf of abused and neglected children in foster care.

CASA is driven by the dedication and expertise of caring community members, who contribute their time, energy, and experience to advocate on behalf of children in foster care.



GLA ALA and the 2017 **Justice Jog** supports **CASA/LA** (Court Appointed Special Advocates), a critical organization in helping children in the foster care system.

Since 2011, the Justice Jog has raised over \$400,000 for CASA/LA programs and services benefiting foster children in Los Angeles County. There are more than 30,000 children in foster care in LA County and the need is greater than ever for CASA/LA to recruit and train more volunteers for one-on-one advocacy. Currently, CASA/LA is serving 900 children in foster care with direct services.
